

## **Official Rules and Regulations for “Enter to Win Miromar Outlets Gift Card” Contest.**

Contest is open to individuals age 18 and older who are legal residents of the United States and Canada only. **HOW TO ENTER:** Fill out the entry form included in the advertisement or an Enter to Win paper or digital form and submit it to the Mall Office or Visitors Information Kiosk located at within Miromar Outlets at 10801 Corkscrew Road, Estero, Florida 33928.

**LIMIT:** One entry per person/household during the entire Contest entry period.

Miromar Outlets Gift Card (“Prize”).
